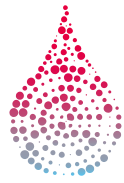

Big data for big questions

To answer the key outstanding questions about blood cancer, researchers need harmonized and high-quality data on treatment outcomes in thousands of patients. Such data are currently contained in a unique HARMONY database from clinical studies and public registries spread across the world, each utilizing its own data format.

“HARMONY has developed technical and organizational procedures to overcome obstacles to clinical data sharing. This enables us to assemble anonymized data records from thousands of European patients into one harmonized data Platform. The HARMONY Big Data Platform soon will contain more than 60,000 anonymized patient records, making it one of the largest databases of its kind. The aim is to expand the Platform to at least 100,000 patient records within the lifetime of the HARMONY Alliance.”

## #BigDataforBloodCancer: Become involved in the HARMONY Alliance!

Various Research Project teams are already using the Big Data Platform to answer critical research questions that cannot be addressed with other methods. The HARMONY Alliance and the EBMT would like to encourage the EBMT members to become an Associated Member and to contribute data to the HARMONY Big Data Platform. The more high-quality data can be collected,

the sooner better tailored treatments to the needs of individual patients can be realized. By becoming a HARMONY Associated Member organizations can submit research proposals; become part of dedicated research groups that includes skilled data scientists and can contribute to scientific publications under the umbrella of HARMONY. Effort for sharing data are compensated.

Co-operative working groups, hospitals and academic institutions are invited to collaborate and contribute data to the HARMONY Alliance. Already over 100 public-private organizations from 17 European countries joined us.
